Beach Restoration by Mike Kelly

The US Army Corps of Engineers has released the latest Rudee Inlet Dredging Solicitation. It is posted at https:// sam.gov/opp/7ce2478af0104532b9da73b1a867e725/view. Within it is the placement of sand on the Croatan Public Beach.

Vendor responses are due August 30th. It could slide a week or two depending on questions. If it doesn't, then I would expect the award to be made by mid-October. Work would begin 15-days after the award and must be completed within 180-days. Once they start, it should not take that long.

The Corps' estimated cost is between \$1 Million and \$5 Million. The last solicitation single bid was approximately \$9 M. So, there was no award. Hopefully, the second time around, they will get bids withing range.

Short-term Rental by Mike Kelly

This is a recap of the city Council session of 13 July 2021. For more detail, see bookmarked agenda at https://

www.vbgov.com/government/departments/city-clerk/city-council/Pages/ fault.aspx. The items are on pages 269-270.

Items A and B were not passed at the 6 July meeting. However, they will be opened at the 7 September meeting for another vote. The reason is that there is consensus that an OR (Resort area) Overlay District should be creatbut not the North End. Intent appears to be to vote the OR Overlay District in. There is a slight danger that the North End could be added although the cussion clearly indicated that the Council would not support that.

Item C was approved. This says that STRs can only be in overlay districts ur less grandfathered with proper registration and permits. No new STRs except in Sandbridge (and the OR Overlay District if approved on 7 Sep.)

Item D is the section that adds additional safety requirements. This was deferred to the 7 Sep. meeting.

Item E was approved. This section covers the rules and regulations for STRs in overlay districts. Importantly, this is the section that requires that a petition to become an overlay district requires agreement by 75% of "an identified community."

Item F was approved. This says that any applications submitted after the transition date of 20 Oct 20, are subject to the regulations in-place at the time they are considered by the PC or City Council. As a result of this vote, any application submitted after 20 Oct 20 and not already reviewed/approved by the Planning Commission would be stopped and no longer allowed to apply for an STR CUP.

Of note, these other important comments were made:

- Concern was raised about enforcement of the rules and that attention must be paid to that.
- There is no list of STR complaints.
- "All" problems seem to be associated with the illegal STRs. (Not really true, but since there is no STR Complaint List, people can say anything.)
- The STR permitting process falls under zoning. Violation fines are \$200. That is the maximum amount the State Law allows for any zoning violation. It can go to \$500 with repeat violations.
- No one knows how many STRs there are in the city. Part of the reason is that many "grandfathered" properties have not properly registered for an STR through zoning. See next bullet.
- The city needs to the State to change the law and allow the Commissioner of the Revenue to share information with the city on properties that are paying the Transient Tax. That list combined with the approved STR list from zoning would allow identification of "illegal" properties.

Safety, Security Update, Citizen's Advisory Committee (CAC), and Virginia Beach Council of Civic Organizations (VBCCO)

Safety/Security – August 2021:

<u>Virginia Beach Approaching Grim Milestone</u>: Police report that the city is on track to set a record for motor vehicle fatalities this year. Most of these fatal accidents are caused by speed and/or impairment. On the speed issue – police report frequent stops of individuals traveling in excess of 100 MPH, even on feeder roads such as General Booth and Oceana Boulevards.

<u>Street Parking</u>: Please respect the time window for street parking on Vanderbilt and Surfside. Vehicles are being parked (and ticketed) outside of the prescribed 9:30 AM – 7:00 PM window. Our Security Patrol, Officer Noha, has a day job and is not available to us 24/7. (His off-duty availability is further limited by a shortage of Security Fund donations). Report illegally parked vehicles to police non-emergency number – 757-385-5000. The city's parking management

contractor services the Croatan lot, but <u>not street parking in Croatan</u>. Last word on parking: be sure to clear any obstructing vegetation from No Parking signs. Police cannot enforce if signs are in any way obscured.

Beach Safety:

<u>"Sharps"</u>: Most of the trash that we pick up on the beach is more unsightly than harmful; but a recent report of medical waste washing up on New Jersey shores and forcing beach closures is alarming. If you see syringes, broken glass, sharp plastic or metal (including discarded/lost awning anchors), or fishing gear – please pick it up; mark it; or notify the lifeguards. The most important thing is to <u>do something</u> to prevent others from injuring themselves or worse.

Holes in the sand: Few endeavors are more relaxing than a casual stroll along the beach. While one's gaze may be on their pet, children, or looking for dolphins, they may fall victim to holes dug into the sand by departed beachgoers. If you dig it, please fill it in. We don't need broken ankles, legs, or strained backs that will remind us for life of that summer in Virginia Beach.

Don't dive: Lifeguards, EMS, and physicians are renewing their warnings against diving into the water at the oceanfront. No less than 20 individuals, usually young men at their peak fitness, have been reduced to wheelchairs in the last four years – some have died.

<u>What's in the bag?</u> Small bags of powdery substances are occasionally found on our streets. While the immediate assumption is that they may be drugs, they could also be body powder used by surfers to ease into wet suits. Regardless, please treat such finds as dangerous and <u>do not pick-up with bare hands</u>. People should call police





non-emergency number – 757-385-5000 or 311 and guard the bag. Alternatively, it can be picked up with a plastic bag (as you'd pick up after your dog) and reported to the police after the fact.

Citizen's Advisory Committee (CAC): Held Wednesday, July 14.

Human Trafficking: Police recently rescued a 12-year-old female human trafficking victim here on the Oceanfront. Yes, it still happens; and yes, **it happens here**. The influx of thousands of transients during the summer offers the perfect opportunity for predators to target vulnerable young women (and men) – whether they're runaways or simply looking for a good time without recognizing the risks. Shot-Spotter: The ShotSpotter gunshot detection system was placed into service on July 14 in the Oceanfront area – the first Virginia Beach location to receive this technology. VBPD is deploying Shot-Spotter to high-risk areas to enable their officers to be alerted to gunshots in seconds instead of minutes or possibly not at all, as national statistics have shown that 911 calls occur in fewer than 20 percent of firearm discharges.

Motor Vehicle Thefts: The Second Precinct is now showing an increased incidence in only one crime category – motor vehicle theft. These crimes of opportunity stem from individuals leaving cars running (often to keep air conditioning on) during brief stops for coffee, gasoline, etc. A hot car is not as bad as a hot walk home.

Building Permits: Whether putting in a pool, expanding a deck, or installing a fence, the city will extract its "pound of flesh," in the form of a permit. <u>Permits are a legal requirement and must be displayed throughout the duration of the work</u>. Code Enforcement has police powers re: permits and can cite you, stop work, and in extreme cases, force remediation. Reputable contractors usually include the cost/effort to obtain permits in their estimates. Also, remember to call **Miss Utility (8-1-1)** before beginning any ground-penetrating work to allow utility lines to be marked. Visit Permits & Inspections under http://vbgov.com for forms.

<u>Croatan Spared Short-Term Rental Overlay District Designation</u>: The VB City Council voted in July <u>against</u> overlay districts for short-term rentals unless 75% of the residents vote in favor of such a designation. Croatan was not among the original list of four candidate areas. Virtually all civic leagues and homeowners' associations that are members of the VBCCO have opposed overlay districts. CCL leaders worked long and hard to ensure that our neighborhood retains its residential character, family-friendly ambiance, and that existing short-term rentals are responsibly managed and controlled so as not to disturb the peace and tranquility we moved to Croatan to find.
